Statutory services

In terms of Sec. 25 of the Companies Act 71 of 2008 (replaces Sec. 170 of the Companies Act 61 of 1973, as amended) and Sec. 25 of the Close Corporation Act, Act 69 of 1984, every company and close corporation has to register an official address for the serving of legal documents and delivery of notifications. Furthermore, the statutory documents also have to be kept at the address of the registered office.

Logista Secretarial Services CC which is part of the Logista group of companies has the necessary facilities in place to perform these duties on behalf of the client, which the client can use at an annual fee.

Tax Season for 2011 will kick-off on 1 July 2011. Returns submitted manually to SARS are due 30 September 2011. Non-provisional taxpayers who use e-filing to submit returns, has a deadline of 25 November 2011 and provisional taxpayers' returns submitted through e-filing deadline is 31 January 2012.

Half year IRP5 reconciliation for 2012

This reconciliation for the 6 month period from March to August 2011 is due before or on 31 October 2011 and needs to be lodged with SARS by this date.
